

## **Creganna Medical Privacy Policy**

This Privacy Policy applies to the worldwide websites of Creganna Medical Unlimited, Ireland (“Creganna Medical”) that is part of TE Connectivity Corporation (together with its global affiliates referred to as: “TE”).

The privacy policy explains how we collect, process, share, secure and store personal information (information and data that can be used to identify an individual) of our websites' users. It also describes your choices regarding use, access and correction of your personal information. Creganna Medical is committed to protecting any personal information that you may provide to us or that we collect during your visit to our websites (“Personal Data”).

### **Use of Our Websites**

In general, you can visit our websites without telling us who you are or revealing Personal Data, except for your Internet Protocol (“IP”) address. During your visit to our websites, we collect certain information automatically, such as browser, device type, domain, host names, pages viewed and viewing patterns, as well as the country/region where users are located. This information allows us to better determine user needs and interests to drive improvements to website content and functionality, and to enhance the overall customer service experience.

### **Collection, Processing, and Use of Personal Data / Consent**

We collect, process and use your Personal Data to the extent necessary primarily for the following purposes:

- Website Registration
- Request for Information Regarding Product/Service
- Website Features and Updates
- Product/Service Enhancements and Information
- Webinar/Training Registration
- Survey Participation
- Customer Service Support
- Job Applications
- Product Information Center Support
- Sample Requests
- Sales Transactions and Support
- Export Controls
- Participation in Public Forums
- Social Media Advertising
- Customize Account Preferences
- Marketing Purposes

Usually, the Personal Data you provide voluntarily will only be used to respond to an inquiry you make or to process your request, e.g. to fulfil a legal obligation or a quasi-legal obligation with you. Personal Data collected from you may include your name, address, telephone, fax number, title/position, company, mailing address or e-mail address, billing information among other information. You may refuse any request for Personal Data. However, if you choose not to provide certain Personal Data, you may not be able to take advantage of certain Creganna Medical programs and websites features.

### **Exchange of Personal Data**

Just like other TE affiliates, Creganna Medical uses TE global customer data systems that are located in the US for storing and processing your personal data.

TE affiliates and service providers we use for the processing of customer data are contractually required to appropriately protect your Personal Data and not use it for any other purpose than for which it was collected or for rendering the contracted services. We will release your Personal Data if you direct us to do so or, if we are required by law. This can be to respond to subpoenas, court orders or legal process or to defend our legal rights. We may also need to respond to lawful requests by public authorities, including to meet national security or law enforcement requirements, or in other limited circumstances permitted by the law (including fraud protection and risk reduction).

We may share your Personal Data in the event of a sale of all, or a portion of our business, stock, or assets that relate to your Personal Data.

### **International Data Transfers**

To provide adequate protection for the international transfer of Personal Data, besides using data transfer agreements, Creganna Medical, relies on the certification of TE Connectivity for the EU-U.S. Privacy Shield Framework. This program is set forth by the U.S. Department of Commerce and relates to the collection, use, and retention of personal information transferred from the European Union to the United States. ### **Cookies**

We use automatic data collection tools, including cookies, web beacons, e-tags and Javascript, to obtain information when your web browser accesses the websites. These tools allow us to recognize your computer or other device and your customized preferences when you visit and use our websites. The tools, including web analytics provided by third parties, such as Google Analytics, gather data including but not limited to browser type, IP address, and clickstream patterns (pages viewed, and links clicked). ### **Children's Privacy**

Our websites are not intended for persons under 16 years of age. We do not knowingly solicit or collect personal information from or about children, and we do not knowingly market our products or services to children. If we learn we have collected Personal Data regarding a child under the age of 16, we will delete that Personal Data.

### **Security of Collected Personal Data**

Creganna Medical maintains reasonable physical, electronic, and administrative safeguards to protect your Personal Data from unauthorized or inappropriate access, accidental or intentional manipulation, loss and destruction. Our security procedures are continually enhanced. We restrict access to your Personal Data to those employees who need to know the information to respond to your inquiry or request. Employees who misuse personal information are subject to disciplinary action. However, the security of the internet cannot be

### **Data Retention. Accessing, Amending, Storing Your Personal Data and Opt Out Rights**

We will retain your information for as long as your account is active, or as needed to provide you services. Upon request Creganna Medical will provide you with information about whether we hold or process any of your Personal Data. You may review and update the Personal Data that you provide to Creganna Medical through our websites, or request to have your Personal Data amended, blocked or removed by contacting us as described below. We will respond to your request within the legally applicable timeframes. If you request removal of your Personal Data, you understand and agree that residual information may continue to reside in Creganna Medical records and archives as far as permitted by law (e.g., for accounting purposes). However, we agree not to use such Personal Data for business purposes.

You may opt out of the collection and processing of your Personal Data at any time as well as from onward transfer of your Personal Data to TE or third parties, by contacting us as described below. We will ask for your prior consent if we would like to use your Personal Data for a materially different purpose than for which it was collected or authorized.

You may sign-up to receive email newsletters from us. You may “unsubscribe” to any online contact from us at any time by following the instructions set forth on the email message, or by contacting us as described below.
